Al Khaleej Takaful Insurance Company (AKHI)

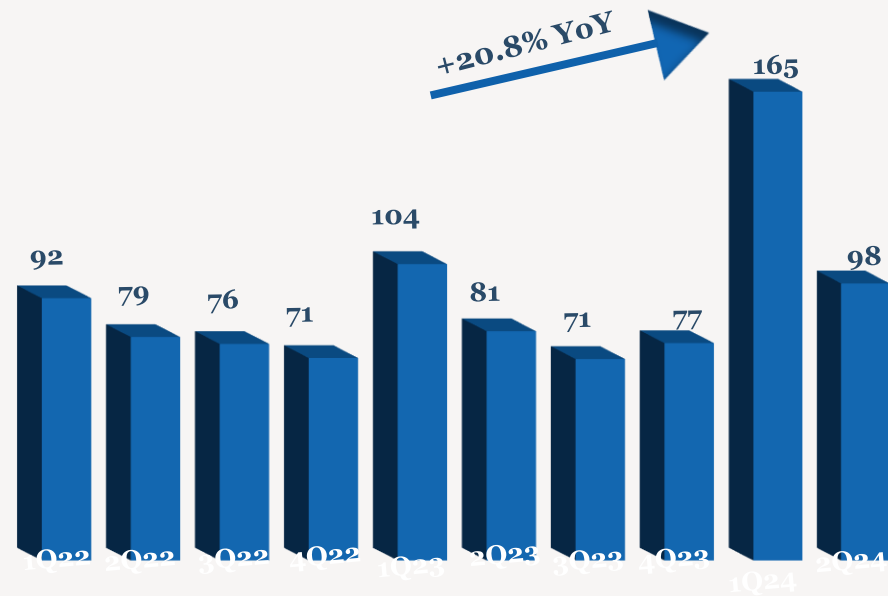
- > **Net profit increased 2.5% YoY to QR16mn (-41.8% QoQ) in 2Q2024** primarily due to higher total takaful revenue. For 6M2024, net profit fell 1.9% to QR43mn.
- > **Gross written premium rose by 20.8% YoY to QR98mn (-40.9% QoQ) in 2Q2024.** For 6M2024, gross written premium rose 41.8% to QR263mn.
- > **Net earned premium (NEP) of QR47mn came lower by 3.8% YoY (-9.1% QoQ) in 2Q2024.** For 6M2024, NEP was up 5.2% to QR98mn.
- > **For 2Q2024 Loss ratio came to 66.4% (vs 52.6% in 2Q2023).** For 6M2024, loss ratio came to 59.0% (vs 55.2% in 6M2023).
- > **For 2Q2024, EPS came to QR0.062 vs. QR0.060 in 2Q2023.** For 6M2024, EPS came to QR0.167 vs. 0.171 in 6M2023.
- > **As of 31st July 2024, the stock has decreased 19.6% YTD, underperforming the QSE index, which was down by 6.6% YTD.**

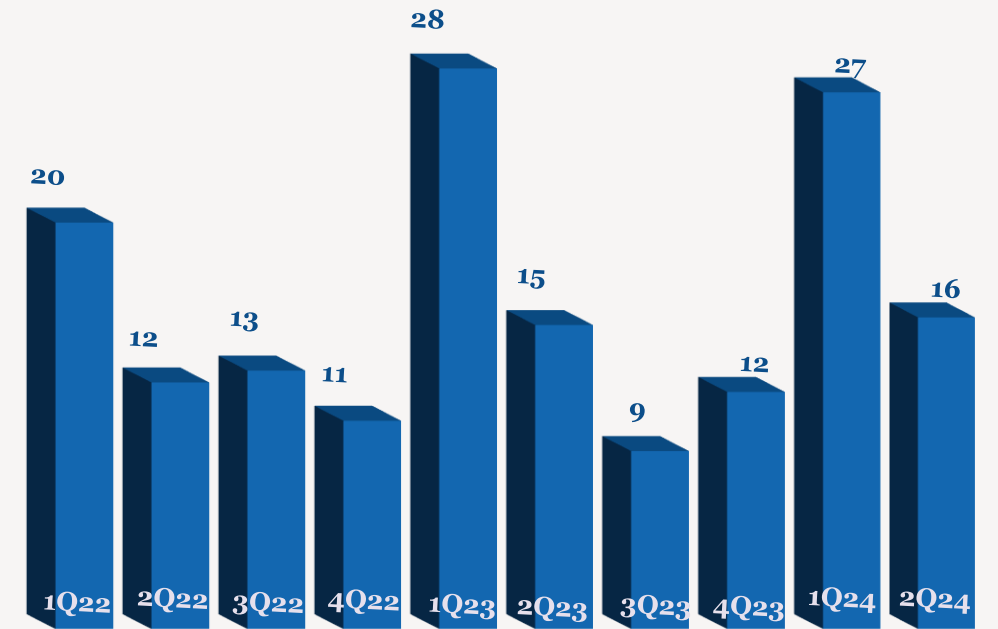

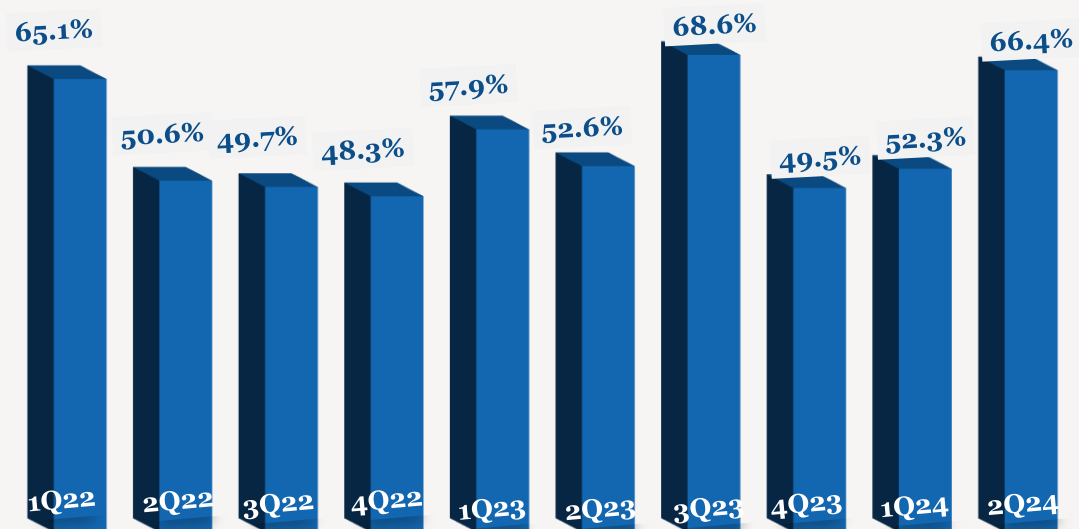
Quarterly Gross Written Premium Trend (QRmn)



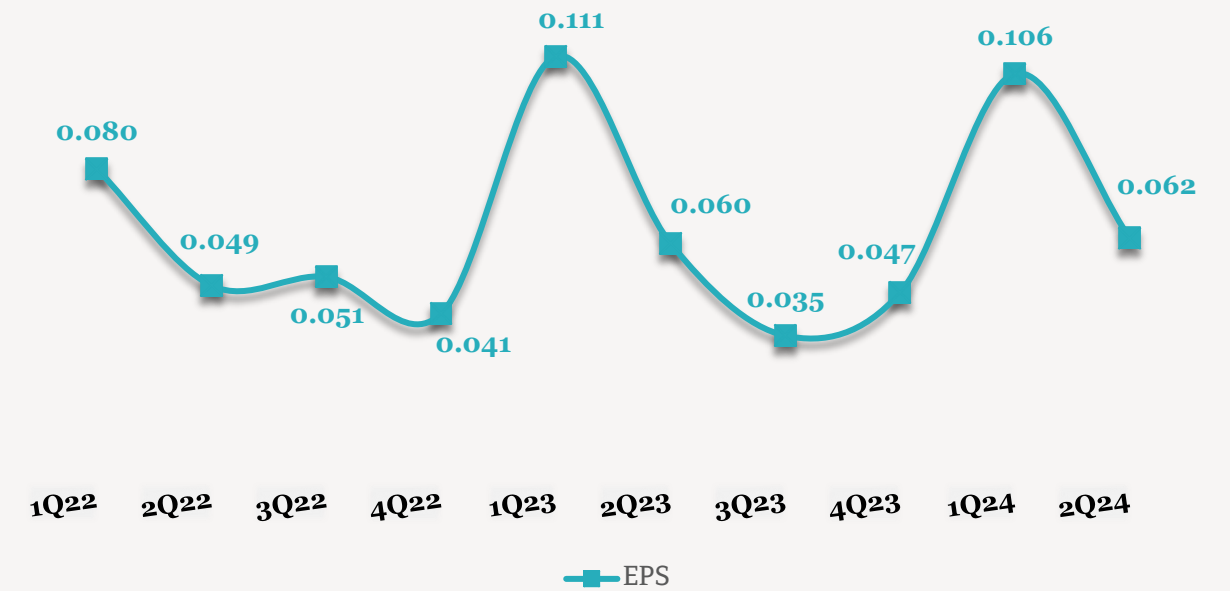
Quarterly Earnings Trend (QRmn)
