

Dlala Brokerage and Investment Holding Company (DBIS)

- > Net profit came to QR0.4mn (Vs. Loss of QR5.0mn in 1Q2024) in 2Q2024 as against the loss of QR0.5mn in 2Q2023 primarily due to a higher fair value gains on investment securities of QR2.3mn in 2Q2024. For 6M2024, net loss came at QR4.5mn as against the loss of QR2.9mn in 6M2023.
- > Brokerage Commission Income decreased by 14.0% YoY (-13.8% QoQ) to QR3.3mn in 2Q2024. For 6M2024, brokerage commission income was down 8.3% YoY to QR7.1mn.
- > Gross profit decreased by 24.9% YoY to QR1.8mn (-10.1% QoQ) while the corresponding margin declined by 7.9ppts YoY to 54.0% in 2Q2024. For 6M2024 gross profit was down 21.6% to QR3.7mn.
- > For 2Q2024, EPS came at QR0.002 vs. Loss Per Share of QR0.003 in 2Q2023. For 6M2024, Loss per share was 0.024 vs 0.015 in 6M2023.


> As of 5th August 2024, the stock has decreased 13.6% YTD, underperforming the QSE index, which was down by 7.1% YTD.




Quarterly Brokerage Commission Income Trend (QRmn)




Quarterly Margin Trend
