

Mannai Corporation (MCCS)

- > For 3Q2024 net loss came in at QR5mn vs net profit of QR5mn in 3Q2023, and net profit of QR39mn in 2Q2024, primarily due to higher general and administrative expenses. For 9M2024, net profit rose 46.4% to QR63mn.
- > **Revenue decreased by 3.8% YoY to QR1,267mn (-10.9% QoQ) in 3Q2024**. For 9M2024, revenue was up 2.9% to QR4,071mn.
- > Gross profit grew 2.4% YoY to QR218mn (-18.4% QoQ) and the corresponding margin came at 17.2% (vs 16.2% in 3Q2023) in 3Q2024. For 9M2024, gross profit increased 8.3% to QR738mn.
- > Operating profit fell by 16.2% to QR59mn (-27.6% QoQ) while the corresponding margin was down to 4.7% (vs 5.4% in 3Q2023) in 3Q2024. For 9M2024, operating profit was down 8.7% to QR218mn.
- For 3Q2024, Loss per share came at QR0.011 vs. Earnings per share of QR0.010 in 3Q2023. For 9M2024, EPS came at QR0.137 vs. QR0.094 in 9M2023.


> **As of 22nd Oct 2024, the stock has decreased 8.5% YTD,** underperforming the QSE Index, which was down by 2.4% YTD.




Quarterly Sales Trend (QRmn)




Quarterly Margin Trend
