

Earnings Flash Note Medicare Group 3Q 2023 / 9M 2023



Medicare Group (MCGS)

- > Net profit decreased by 31.8% YoY to QR14.0mn (-19.9% QoQ) owing to lower revenue and higher general & administrative expenses in 3Q2023. For 9M2023, net profit was down by 10.1% YoY to QR50.4mn.
- > Operating income of QR109.1mn declined by -4.2% YoY (-8.1% QoQ) in 3Q2023 while for 9M2023, it was broadly flat at QR356.3mn (-0.9% YoY).
- > Gross profit came at QR39.7mn (-12.2% YoY, -11.5% QoQ) while the corresponding margin dropped by 3.3ppts YoY (-1.4ppts QoQ) to 36.3% in 3Q2023.
- > Operating profit decreased by 32.9% YoY to QR13.4mn (-20.1% QoQ) and margin declined by 5.3ppts YoY (-1.9ppts QoQ) in 3Q2023.
- > For 3Q2023, EPS came at QR0.05 vs. QR0.07 in 3Q2022 while for 9M2023, EPS was 0.18 vs 0.20 in 9M2022.

- > As of 23rd Oct 2023, the stock has decreased 11.5% YTD, underperforming the QSE index, which was down by 9.0% YTD.
- > The stock is currently trading at a TTM P/E multiple of 19.3x, lower than its 3Y historical average of 25.7x. We expect to trim our FY2023 estimates of net profit by between 5-8%, and we lower our price target to QR6.072 from QR7.144 to reflect 3Q2023 performance.






Quarterly Operating Income Trend (QRmn)
