

MEEZA QSTP (MEZA)

- > Net profit decreased by 25.7% YoY to QR12mn (-33.5% QoQ) in 3Q2024 owing to a fall in revenue. For 9M2024, net profit fell by 8.7% to QR42mn.
- > Revenue fell by 10.5% YoY to QR80mn (-15.9% QoQ) in 3Q2024. For 9M2024, revenue was down 16.6% to QR259mn.
- > Gross profit was down by 3.2% YoY to QR25mn (-23.8% QoQ) and margin rose to 31.7% (+2.4ppts YoY; -3.3ppts QoQ) in 3Q2024. For 9M2024, gross profit was up 1.1% to QR85mn.
- > Operating profit fell 4.8% YoY (-32.9% QoQ) to QR14mn in 3Q2024 while the corresponding margin rose to 17.0% (+1.0ppts YoY, -4.3ppts QoQ). For 9M2024, operating profit fell 2.8% to QR47mn.


- > **For 3Q2024, EPS came to QR0.019 vs. QR0.025 in 3Q2023**. For 9M2024, EPS came to QR0.06 vs QR0.07 in 9M2023.
- > As of 22nd Oct 2024, the stock has increased 10.3% YTD, outperforming the QSE Index, which was down by 2.4% YTD.
- > For now, we maintain our PT of QR 4.03/share and our Accumulate rating.




Quarterly Sales Trend (QRmn)




Quarterly Margin Trend
