

MEEZA QSTP (MEZA)

- > Net profit increased by 29.8% YoY to QR18mn (+52.2% QoQ) in 4Q2024 owing to a rise in revenue. For FY2024, net profit was up 0.4% to QR60mn.
- > **Revenue rose by 2.8% YoY to QR115mn (+43.4% QoQ) in 4Q2024**. For FY2024, revenue was down 11.5% to QR374mn.
- > Gross profit was up by 8.4% YoY to QR33mn (+31.9% QoQ) and margin rose to 29.1% (+1.5ppts YoY; -2.5ppts QoQ) in 4Q2024. For FY2024, gross profit was up 3.1% to QR118mn.
- > Operating profit grew 20.5% YoY (+41.7% QoQ) to QR19mn in 4Q2024 while the corresponding margin rose to 16.8% (+2.5ppts YoY, -0.2ppts QoQ). For FY2024, operating profit rose 3.0% to QR67mn.


- > For 4Q2024, EPS came to QR0.03 vs. QR0.02 in 4Q2023. For FY2024, EPS came to QR0.09 (flat YoY).
- > As of 4th Feb 2025, the stock has decreased 4.8% YTD, Underperforming the QSE Index, which was up by 0.8% YTD.
- > The stock is currently trading at TTM P/E multiple of 33.5x. For now, we maintain our PT of QR 4.03/share and our Accumulate rating.
- > The Board of Directors proposed a cash dividend of QR51.9mn (i.e QR0.08 per share) subject to approval of the Annual General Assembly.




Quarterly Sales Trend (QRmn)
