



Mekdam Holding (MKDM)

- > Net profit increased 8.6% YoY (-21.3% QoQ) to QR11mn in 1Q2024, driven by lower finance cost and higher revenue.
- > Revenue rose 13.7% YoY to QR145mn (-2.7% QoQ) in 1Q2024.
- > Gross profit increased by 4.9% YoY to QR23mn (-9.3% QoQ) while the corresponding margin fell 1.3ppts YoY (-1.2ppts QoQ) to 15.8% in 1Q2024.
- > Operating profit of QR11mn was down by 6.7% YoY (-21.0% QoQ) and the margin came at 7.9% (-1.7% YoY, -1.8ppts QoQ) in 1Q2024.
- > For 1Q2024, EPS came at QR0.078 vs. QR0.100 in 1Q2023.


- > As of 28th April 2024, the stock has decreased 2.3% YTD, outperforming the QSE index, which was down by 10.7% YTD.
- > The stock is currently trading at a TTM P/E multiple of 13.0x, lower than its 2Y historical average of 14.9x.




Quarterly Sales Trend (QRmn)




Quarterly Margin Trend
