



Qatar Fuel Company (QFLS)

- > Net profit in 1Q2024 increased by 9.1% YoY to QR243mn (-10.6% QoQ) primarily due to higher revenue and other income.
- > Revenue increased by 3.2% YoY to QR6,832mn (-8.2% QoQ) in 1Q2024.
- > Gross profit rose by 6.9% YoY to QR186mn (+36.4% QoQ) and the corresponding margin came at 2.7% (+0.1ppts YoY; +0.9ppts QoQ) in 1Q2024.
- > Operating profit grew by 11.6% to Q105mn (+2.7% QoQ) while the corresponding margin improved by 0.1ppts YoY to 1.5% (+0.2ppts QoQ) in 1Q2024.
- > For 1Q2024, EPS came at QR0.24 vs. QR0.22 in 1Q2023.


- > **As of 30th April 2024, the stock has decreased 12.8% YTD,** underperforming the QSE index, which was down by 10.2% YTD.
- > The stock is currently trading at a TTM P/E multiple of 14.3x, lower than its 3Y historical average of 16.1x.


Quarterly Sales Trend (QRmn)




Quarterly Margin Trend
