



Qatari Navigation (QNNS)

- > Net profit increased by 0.5% to QR365mn (+127.6% QoQ) in 1Q2024 due to higher share of results of associates (+34.8% YoY, +24.1% QoQ) and lower operating supplies & expenses line item (-23.0% YoY, -26.2% QoQ).
- > Revenue declined by 2.5% YoY (+4.6% QoQ) to QR747mn in 1Q2024.
- > Gross profit rose 7.8% YoY to QR481mn (+51.5% QoQ) while the corresponding margin came at 64.4% in 1Q2024 (vs. 58.3% in 1Q2023).
- > Operating profit of QR208mn was down by 0.9% YoY (+537.9% QoQ) and margin came at 27.9% in 1Q2024 (vs. 27.4% in 1Q2023).


- > For 1Q2024, EPS came at QR0.321 vs. QR0.320 in 1Q2023.
- > As of 30th April 2024, the stock has increased 9.6% YTD, outperforming the QSE Index, which was down by 10.2% YTD.
- > The stock is currently trading at TTM P/E multiple of 11.7x, higher than its 2Y historical average of 11.0x. For now, we maintain our PT of QR13.10/share and our Outperform rating.


Quarterly Sales Trend (QRmn)





Quarterly Margin Trend
